The undersigned Detective Eric Jensen - SOUTH SALT LAKE POLICE DEPARTMENT, Agency Case No. 08G005128, and Investigator Sgt. Alex Huggard - SALT LAKE COUNTY DISTRICT ATTORNEY'S OFFICE, Agency Case No. 2009-2790, upon a written affidavit states on information and belief that the defendant, IETI DAVID MAGEO,

COUNT I

AGGRAVATED BURGLARY, 76-6-203 UCA, a First Degree Felony, as follows: That on or about July 04, 2008 at 393 East Maxwell Lane, in Salt Lake County, State of Utah the defendants, IETI DAVID MAGEO, RICKY IAN PEACE, and IETITAIA TAVITA NUUSILA, as parties to the offense, entered or remained unlawfully in a building or any portion of a building with intent to commit a felony or theft or commit an assault on any person and in the course of attempting, committing, or fleeing from said burglary the defendant, or another participant in the crime, caused bodily injury to any person who was not a participant in the crime; used or threatened the immediate use of a dangerous weapon against any person who was not a participant in the crime.

NOTICE IS GIVEN pursuant to Utah Code Annotated §76-3-203.1, that the defendant is subject to an enhanced penalty as provided in that section because the above offense was committed in concert with two or more persons.

COUNT II

AGGRAVATED ASSAULT, 76-5-103 UCA, a First Degree Felony, as follows: That on or about July 04, 2008 at 393 East Maxwell Lane, in Salt Lake County, State of Utah the defendants, IETI DAVID MAGEO, RICKY IAN PEACE, and IETITAIA TAVITA NUUSILA, as parties to the offense, did commit assault as defined in Utah Code §76-5-102 and intentionally caused serious bodily injury to another.

NOTICE IS GIVEN pursuant to Utah Code Annotated §76-3-203.1, that the defendant is subject to an enhanced penalty as provided in that section because the above offense was committed in concert with two or more persons.

COUNT III

RIOT, 76-9-101 UCA, a Third Degree Felony, as follows: That on or about July 04, 2008 at 393 East Maxwell Lane, in Salt Lake County, State of Utah the defendants, IETI DAVID MAGEO, RICKY IAN PEACE, IETITAIA TAVITA NUUSILA, LISA RITA AIONO, MARSHA RAE FINAU, ANGELINA JANA E DIBELLA, and TUPULULULULU LATU, as parties to the offense, did simultaneously with two or more other persons engage in tumultuous or violent conduct and thereby knowingly or recklessly creates a substantial risk of causing public alarm; or assemble with two or more other persons with the purpose of engaging, soon thereafter, in tumultuous or violent conduct, knowing, that two or more other persons in the assembly have the same purpose; or assemble with two or more other persons with the purpose of committing an offense against a person or property of another who he supposed to be guilty of a violation of law, believing that two or more other persons in the assembly have the same purpose; and, in the course of and as a result of the conduct, any person suffered bodily injury, or substantial property damage or arson occurred, or the defendant was armed with a deadly weapon.

THIS INFORMATION IS BASED ON EVIDENCE OBTAINED FROM THE FOLLOWING WITNESSES:

Eric Jensen, David Bell, Darren Carr, Megan Dunyon, Daniel Fair, John Ferguson, Emily Gammell, Garrison Gammell, Suzanne Gustin, David Hurst, Shane Johnson, Roger Kraft, Shaun Lyman, Angela Micklos, Travis Peterson, Tupakk Renteria, Joe Sutera, and Craig Watson.

AFFIDAVIT OF PROBABLE CAUSE:

That on or about July 4, 2008, at 393 East Maxwell Lane in Salt Lake County, State of Utah, that officers responded to the above location after **Tapulululu Latu** called 911 and reported that her family was assaulting her neighbors because they had taken two children. At the scene and in further interviews with police, **Tapulululu Latu** stated her daughter and her nephew couldn't be found at her house during an all night family/friend party. **Tapulululu Latu** stated that she went to David Bell's house to look for the children. She found the children at David Bell's house. She went back to the party with the two children and announced that she had found them in the neighbor's house. **Tapulululu** stated that, **Ieti Mageo, Ricky Peace, Lisa Aione, Marsha Finau and Ioane John Falaniko** who were at the party stood up, and rushed over to the David's house.

Daniel Fair told investigative detectives that he woke up to **Tapulululu Latu**, two children, and David Bell in his room. Daniel heard **Tapulululu Latu** say, "You better lock the doors because I am going to tell my family." Daniel Fair said he and David Bell went down and made sure the doors were locked. Daniel Fair said he went to the front door and David Bell went to the back. Daniel Fair said at that point people began banging and trying to break through the front door. Daniel Fair was able to identify **Ieti Mageo and Lisa Aiono** as two of the people he could see trying to get in through the front door. Daniel Fair said that **Lisa Aiono** was behind **Ieti Mageo** yelling. Daniel Fair stated while he was holding the door he was attacked from behind by **Ricky Peace**. Once **Ricky Peace** had a hold of Daniel Fair the others came in and began assaulting him. Daniel Fair identified **Ieti Mageo, Ricky Peace, and Iititaia Nuusila** as the men who were passing him around punching and hitting him with hard objects. Daniel Fair said when they finished assaulting him **Ricky Peace** threw a salt shaker at his head. Daniel sustained severe lacerations that required staples, a fractured eye socket, fractured hand, a broken nose and a concussion. Officers found a chair, frying pan, and a TV monitor where Daniel Fair was assaulted that had large quantity of blood on them and which were consistent with object that caused some of Daniel Fair's injuries.

David Bell informed police that after **Tapululululu Latu** left his home, Daniel Fair went to the front door and he went to the side carport door to make sure it was locked. A short time later multiple people attempted to enter the residence. While holding the side door shut David Bell was pushed from behind and was pulled from the house by his hair, body-slammed to the ground, outside in the carport, and held down by an unknown individual. While being held down, an unknown female came up to him and cut his neck and chest with a piece of glass and another women, later identified as **Angie Dibella**, kicked him in the forehead.

Ietitaia Tavita Nuusila was found at the scene and he gave police the false name of **Ieti Faamausi**. Vaimaila Ieti Faamausi is an actual person, she is a 77 year old female who lives in Murray Utah. **Ietitaia Tavita Nuusila** told Suzanne Gustin that all the parties involved, were in **Tapululululu Latu** yard, when she came back to the party with the two children in her arms, that he and the other got up, and went to David Bell's house. **Ietitaia Tavita Nuusila** admitted that he had chased David Bell into the back yard and hit him along with the some of the other people from the party.

Ieti Mageo told your affiants that **Tapululululu Latu** came back to the party holding the two children and told them she had found the children at David Bell's house. **Ieti Mageo, Ricky Peace, Lisa Aiono, Marsha Finau, and Ietitaia Tavita Nuusila**, then went over to David Bell's house. **Ieti Mageo** stated that he remembers reaching through a window and moving the blinds but does not recall breaking the window. **Ieti Mageo** had a cut on his elbow and scrapes on his knuckles.

Ricky Peace told Detective Joe Sutura he went over to David Bell's house, went to the back door, kicked it open, and entered the basement. **Ricky Peace** saw two males holding the front door and side doors shut. **Ricky Peace** said he pushed the thinner male away from the door and punched the heavier male in the side of his chest. **Ricky Peace** then struggled with both males to allow the door to be opened so the others could come in. **Ricky Peace** said at one point he saw the thinner male escaping out the back and he chased after him but was unable to locate him. **Ricky Peace** stated that he did not know how many times he hit the males. Your affiants stated that David Bell matches the description of the thinner male while Daniel Fair matches the description of the heavier male.


Marsha Finau testified at trial on September 21, 2009, that she was over at David Bell's house and directed **Ricky Peace, Ietitaia Tavita Nuusila** and other individuals to David Bell's hiding place and eventual flight.
